

## Sciota Township Board Meeting – April 11, 2020

The April 11, 2022, meeting of the Sciota Township Board was called to order by Supervisor Matthews at 7:00 p.m. at the Sciota Township Hall. The Pledge of Allegiance was given by all. Members present were Supervisor Matthews, Clerk Parker-Wing, Treasurer Palmer, Trustee Reed; Trustee Vondrasek was absent. Guests present were Floyd Koerner, Nancy Koerner, Charlene Austin, Sandra Chavez, Mike Dowler, Diane Dowler, David White, and Diane Baclawski.

**MINUTES:** Reed moved to approve the March minutes with changes (add guests present), seconded by Palmer—Motion approved by all.

**TREASURER REPORT:** Parker-Wing made a motion to accept the Treasurer’s report and place it on file, seconded by Reed—Motion approved by all. General fund \$176,160.85; Tax Fund \$11,973.22; IMMA fund \$33,952.79; COVID Relief fund \$93,477.48.

- The township received a letter of support (for signature) from the City of Laingsburg regarding a grant for a new city boat launch.
