

Sciota Township Board Meeting – November 12, 2018

The November 12, 2018 meeting of the Sciota Township Board was called to order by Supervisor Matthews at 7:00 pm at the Sciota Township Hall. The Pledge of Allegiance was given by all. Members present were Supervisor Matthews, Clerk Koerner, Treasurer Doyle, Trustee Vondrasek and Trustee Reed. Guests present were Hank Cross, Floyd Koerner, Jr., Dave White, Charlene Austin, Lynn Gruesbeck, Mike and Diane Dowler, Diane Baclawski and Karen Anderson.

The minutes of the October meeting were approved, with a correction on the date of the meeting, on a motion by Vondrasek, and seconded by Reed. Koerner moved to accept the treasurer's report and place it on file.

Commissioner report: None

Board reports: Matthews announced a land use conference and moved to send Vondrasek, Howard Pierce and himself and send the check immediately to meet early deadline. Koerner seconded the motion and it passed. Koerner gave an update on the election.

Planning commission: We will wait until next month to do the lot line adjustment as the applicants could not be present tonight.

Emergency Services: There were 52 fire and rescue runs in Sept. and 488 for the year to date. There were 32 ambulance runs in Sept. and 259 for the year to date.

Old business: Most of the larger non-cleared checks have been taken care of. There are some smaller ones we may have to send to the state.

New business: Koerner moved to make the following budget adjustments:

From contingency fund: To elections: forms and supplies \$350

From hall and cemetery: \$40 from building maintenance to lot maintenance

Reed seconded the motion and it passed.

Marihuana ordinance: Matthews and Reed will see our attorney for input on this.

The clerk printer has died. Matthews move to allow new clerk to spend up to \$125 for a new printer for her office. Reed seconded the motion and it passed.

New officer training is scheduled. Matthews moved to send Wing and Vondrasek to the training and pay so we meet the early deadline.

Diane Dowler reported that the Consumer Price Index was 2.4% this year.

Dave White said Pat and he had worked on the toilet but it needs some new parts.

Reed moved to pay bills. Vondrasek seconded the motion and it passed.
