Sciota Township Board Meeting – July 9, 2018

(draft minutes)

The July 9, 2018 meeting of the Sciota Township Board was called to order by Supervisor Matthews at 7:00 pm at the Sciota Township Hall. The Pledge of Allegiance was given by all. Board members present were Supervisor Matthews, Clerk Koerner, Treasurer Doyle, Trustee Reed and Trustee Vondrasek. Guests present were Hank Cross, Sharron Carr, Floyd Koerner, Jr., Diane Baclawski, Diane Dowler and Lynn and Lois Gruesbeck.

The June minutes were approved on a motion by Doyle, seconded by Reed and passed. Koerner moved to accept the treasurer's report and place it on file. Matthews seconded the motion and it passed.

Commissioner report: None Public Comment: None

Board reports: Matthews reported on the planning meeting that 2 board members and 2 planning commission members will attend on July 19th. There is a Board of Review meeting to be held July 17th. Doyle reported that taxes were coming in. The new computer is fantastic.

Planning commission: Sharron Carr of Laingsburg Rd. was in attendance to see about combining 2 pieces of property. She had all the necessary permits and paperwork. Reed moved we approve the combining of the 2 parcels into one tax bill. Vondrasek seconded the motion and it passed.

Emergency services: Cross reported there were 62 fire and rescue runs in June with 273 year to date and 32 ambulance runs in June with 137 for year to date. There is talk of wage increases to \$15.00 per hour and vacation days given. This will probably mean in increase in revenue will be needed.

Old business: Of the seven uncleared checks 5 can be checked on with the other 2 as questionable. A letter will be sent to see if we get a response before sending the money to the state.

New business: The Public Accuracy test will be held on July 24th at 6:00 pm. Vondrasek moved we spent up to \$300 for paint and labor for the ramp hand rails and some window frames – as far as the paint goes and then decide what else to do. Mike Reed will get with Tracie on the job. Doyle seconded the motion and it passed on an 'all yes' roll call vote.

Second public comment: There was a question on shipping containers being used for storage buildings. No one was aware of a rule against it, but didn't know. Lynn and Lois Gruesbeck purchased 2 cemetery lots. They will meet the sexton and Floyd

Koerner at the cemetery Tues. evening to try to locate the markers.

Koerner moved to pay bills. Reed seconded the motion and it passed.
