Sciota Township Board Meeting – June 11, 2018

(draft minutes)

The June 11, 2018 meeting of the Sciota Township Board was called to order by Supervisor Matthews at 7:00 pm at the Sciota Township Hall. The Pledge of Allegiance was given by all. Members present were Supervisor Matthews, Clerk Koerner, Treasurer Doyle and Trustee Reed. Absent was Trustee Vondrasek. Guests present were Hank Cross, Edwin Parker, Floyd Koerner Jr., Dave White, Mike and Diane Dowler and Jamie Parker-Wing.

The May minutes were approved on a motion by Doyle, seconded by Reed and passed. Reed moved to accept the treasurer's report and place it on file. Koerner seconded the motion and it passed.

Public comment: None

Commissioner report: Commissioner Bartz updated us on what was happening in the county. A vote will be held on the wind energy plan. The county lost \$52,000 due to an erroneous e-mail asking for something to be paid. They are working on an ORV ordinance. The copy we had was the 1st draft and many changes have been made since our planning commission reviewed it. There is some dispute with the city of Corunna on the use of the old Medical Care Facility Buildings.

Board Reports: Matthews reported that an individual was planning on having solar panels installed on Leland Road. Tom Mahoney wants to combine two 5 acre parcels. The board sees no purpose in this but has no objection as it does not conflict with our land use plan. Matthews brought up the planning training 'Hot topics in Planning and Zoning'. Koerner moved to send Diane Baclawski and Vaughn Vondrasek from the planning commission and Phillip Matthews and Mike Reed from the board and to send the check to meet the early discount. Roll call vote showed all yes votes. Koerner shared correspondence. Doyle reported that they are still working on her computer. Tax bills will go out in July.

Planning commission: Edwin Parker was there with a request for a land division. Reed moved to concur with the planning commission and grant the request. Koerner seconded the motion and it passed.

Emergency services: Hank Cross reported on the runs for fire and rescue and the ambulance for April and for the year to date.

Old business: Lisa will send notices to those who haven't cashed a check they received. After these come back we will reissue the check and send balance of uncashed checks to the state as required.

New business: The board publicly thanked Courtney Jorae and her daughters for their work in placing flags and markers on the graves of veterans at the Sciota Cemetery. A thank you card was signed to send to them.

Second public comment: Diane Dowler explained some of the new proposal introduced for changes to assessing.

Matthews moved to pay bills. Reed seconded the motion and it passed.
