## Sciota Township Board Meeting – November 13, 2017

(draft minutes)

The November 13, 2017 meeting of the Sciota Township Board was called to order by Supervisor Matthews at 7:00 pm. The Pledge of Allegiance was given by all. Members present were Supervisor Matthews, Clerk Koerner, Treasurer Doyle and Trustee Reed. Absent was Trustee Vondrasek. Guests present were Floyd Koerner, Jr., Diane Baclawski, Dave White, Kim Palmer, Mike and Diane Dowler and Jeff and Elena Mulder.

The minutes of the October meeting were approved on a motion by Doyle, seconded by Reed and passed. Koerner moved to accept the treasurer's report and place it on file. Matthews seconded the motion and it passed. Due to large increases in fees to be charged by Huntington Bank, Doyle will look into changing banks.

No Commissioner report. No public comment.

Board reports: Matthews reported there were issues with the quality of gravel on part of Garrison road. There is also a meeting on Board Policies coming up. Koerner reported that the polling place accessibility checklist has been completed and sent to the state. There were 21 voters at the last election. We received a refund from the Accident Insurance Fund. Doyle went to the web-site training and is gradually learning what to do. The company is very helpful.

New business: Sciota Township is host to the County MTA meeting to be held on December 5<sup>th</sup>. Matthews will check on using Bennington Township Hall and on getting a speaker for the meeting. Matthews and Koerner will pick up the refreshments.

Some hall maintenance items needing attention are furnace: Matthews will check on. Down spouts and new vacuum cleaner: Reed will check on. Light switch not working: Floyd Koerner will check with Mike Thornburg.

Matthews moved to make the following budget adjustment:

Take \$30.00 from Elections – Equipment and Maintenance and put in Election workers. Reed seconded it and the motion passed.

Public Comment: Dave White questioned the crane on the pond by Garrison Road. Diane Dowler said there wasn't a need for a December Board of Review at this time.

Koerner moved to pay bills. Doyle seconded the motion and it passed.
