## Sciota Township Board Meeting – September 10, 2018

(draft minutes)

The September 10, 2018 meeting of the Sciota Township Board was called to order by Supervisor Matthews at 7:00 pm at the Sciota Township Hall. The Pledge of Allegiance was given by all. Board members present were Supervisor Matthews, Clerk Koerner, Trustee Vondrasek and Trustee Reed. Treasurer Doyle was excused. Guests present were Floyd Koerner, Jr., Diane Baclawski, Charlene Austin, David White, Diane and Mike Dowler and Jamie Parker-Wing.

The minutes of the August meeting were approved on a motion by Reed, seconded by Vondrasek and passed. Koerner moved to accept the treasurer's report and place it on file. Reed seconded the motion and it passed.

Public Comment: Dave White commented on the traffic control on Bennington Road.

Board Reports: Matthews gave information on training being offered by MTA. It will be considered next month. Koerner questioned the board on if there was a need for our auditor to come to a meeting to explain the audit. All were comfortable with their copies of it and didn't feel it was necessary.
