The July 13, 2015 meeting of the Sciota Township Board was called to order by Supervisor Matthews at 7:00 pm. The Pledge of Allegiance was given by all. Board Reports: Matthews said the used tire collection would be on August 1st. MAGNET sent us a letter thanking the township for our contribution. The next meeting of the Looking Glass River drainage will be August 11th. They are looking for the original survey of the river. Koerner - Our township audit will be tomorrow, July 14th. This is our final payment on the parking lot property. Schuman gave the quarterly interest income report. He presented the BS&A software agreement for taxpayers to get info on their taxes. The Metro Act payment will be late and about 10% less. Changes are being proposed for disabled veterans relief from property taxes.

Planning Commission: The County needed paperwork on the Hart property. Bill and Diane will get what we have to them.

Emergency Services: Hank Cross reported 259 fire and rescue runs so far this year. The outside lighting will be changed to LED lights with a cost share from Consumers Energy. They need to update the special assessment roll for the ambulance.

New business: Matthews reported that the cost to replace the culvert on Doyle Rd. will be \$4,900. Schuman moved to replace the culvert. Koerner seconded the motion. There was an 'all yes' roll call vote.
