

Sciota Township Board Meeting – July 11, 2016

(draft minutes)

The July 11, 2016 meeting of the Sciota Township Board was called to order by Supervisor Matthews at 7:00 pm. The Pledge of Allegiance was given by all. Members present were Supervisor Matthews, Clerk Koerner and Trustee Reed. Excused were Treasurer Schuman and Trustee Thelen. Guests present were Floyd Koerner, Jr., Hank Cross, Mike and Diane Dowler and Lisa Doyle.

The minutes of the June meeting were approved on a motion by Matthews, seconded by Reed and passed. There was no treasurer's report.

Public Comment: Lisa Doyle, candidate for Township Treasurer, introduced herself.

Board reports: Matthews reported the gradall will be in the township shortly. If you know of a place it is needed please let him know. Koerner shared correspondence, a MTA meeting notice and the county road commission annual report. Reed stated that he had been to Demis, a CPA, and found out that anyone with a mortgage on property has to have a stamped signed receipt for taxes paid. A cancelled check will not do if audited.
