

Sciota Township Board Meeting – October 14, 2019

FINAL

The October 14, 2019 meeting of the Sciota Township Board was called to order by Supervisor Matthews at 7:01 pm at the Sciota Township Hall. The Pledge of Allegiance was given by all. Members present were Supervisor Matthews, Clerk Parker-Wing, Treasurer Doyle, Trustee Vondrasek and Trustee Reed. Guests present were Diane Baclawski, Diane Dowler, Cindy Garber, Cheryl Lee, John and Theresa Vangeertry, John McDougall.

The minutes of the September meeting were approved with a change of last name for “VanGuertry” to “Vangeertry”, on a motion by Doyle, and seconded by Reed. Reed moved to accept the treasurer’s report and place it on file, seconded by Vondrasek.

There were no public comments

Commissioner Cindy Garber reported that raise requests for Judge’s staff were denied. The Road Commission did not approve additional commissioner appointments at the district hearing. The MERS retirement monetary oversight has been costly.

John McDougall reported statistics for September LSW fire and emergency services. He reminded everyone to get carbon monoxide detectors and change the batteries in fire alarms once per year.

Board reports: Matthews offered MTA training regarding shipping container placement best practices. Parker-Wing has been processing voter registration records. Doyle, Vondrasek, and Reed had no new reports.

Old business: None

New Business: The Board approved the Planning Committee’s recommendations for land variance requests. Parker-Wing read the Commission’s report of new variances and moved to approve the recommendation for Cheryl Lee’s variance request to split one parcel in to two, 2nd by Matthews. Reed moved to approve Harvey Walters Estate variance request to combine two ‘partial’ parcels in to one, 2nd by Vondrasek. Reed moved to approve John and Theresa Vangeertry variance request for a lot line adjustment and land division, 2nd by Vondrasek. The LSW tax assessment hearing was held with no questions or concerns. The \$80 assessment per household will take effect with the winter 2019 tax roll.

No public comment ensued.

Reed moved to pay bills. Vondrasek seconded the motion and it passed.
