## Sciota Township Board Meeting – July12, 2021

The July 12, 2021, meeting of the Sciota Township Board was called to order by Supervisor Matthews at 7:01 p.m. at the Sciota Township Hall. The Pledge of Allegiance was given by all. Members present were Supervisor Matthews, Clerk Parker-Wing, Treasurer Palmer, Trustee Reed, and Trustee Vondrasek. Guests present were Mike and Diane Dowler, Dennis Hill, Frank Suggate, Diane Baclawski, and Cindy Garber.

**MINUTES:** On a motion by Palmer, seconded by Reed, it was moved to approve the June 14, 2021 meeting minutes as written—Motion approved by all.

**TREASURER'S REPORT:** On a motion by Reed, seconded by Vondrasek—Motion approved by all. The Board approved the treasurer's report to be placed on file. Fund balances, General \$150,984.80; Tax \$9,090.80; Money Market \$33,945.76.

**1**<sup>st</sup> **PUBLIC COMMENT.** Frank Suggate had a concern with the Kayak launch area next to his home that will soon be paved. The MDEQ and City of Laingsburg were previously at the site assessing the parking area. Frank's concern was that paving the parking area would bring noisy disruptions to the homeowners of the area.

## COUNTY AND PUBLIC OFFICIALS: Cindy Garber, 6<sup>th</sup> District

- The county has received 6.6 million in COVID relief funds that can be used on public safety. So far, the commission has approved:
  - replacing lighting at the 911 secondary facility (Bennington Township). This is necessary due to the tower not being FAA compliant. Funds will also be used on the fire and EMS radio project, and new servers.
- A grant from the Granger Waste Management company is being used to hire ((1) full-time worker for the county parks and recreation areas. The position will be responsible for cutting and trimming trees and brush. This person will also be performing maintenance on the parks facilities as well.

**LSW EMERGENCY SERVICES:** Dennis Hill reported the LSW recently used the new AED device while enroute to the hospital. They are exploring funding for a new tanker truck and new 'jaws of life' equipment. Dennis gave an overview of emergency services completed for the month of June 2021.

**ASSESSOR:** There will be a Board of Review meeting July 20<sup>th</sup> at 8:00 a.m. The meeting was held to correct clerical errors to poverty and veteran guidelines.

**BOARD REPORTS:** Supervisor Matthews says Doyle Road has not been re-graveled yet. The county needs to be reminded about brush trimming on the north side of Hibbard Road there is a lot of growth still on the roadside. Clerk Parker-Wing says she is following up on unfinished tasks. Treasurer Palmer says summer payments are arriving. Eight tax invoices were returned as undeliverable. She is working with the bank on removing uncashed checks below \$10. Trustees Reed and Vondrasek had no new news.
