Sciota Township Board Meeting – October 12, 2020

The October 12, 2020, meeting of the Sciota Township Board was called to order by Supervisor Matthews at 6.59 p.m. at the Sciota Township Hall. The Pledge of Allegiance was given by all. Members present were Supervisor Matthews, Clerk Parker-Wing, Trustee Reed, Trustee Vondrasek. Absent, Treasurer Doyle. Guests present were Mike and Diane Dowler, Floyd and Nancy Koerner, Diane Baclawski, Charlene Austin, Dave White, and Cindy Garber.

Minutes: Vondrasek moved to approve the September 14 minutes as written, seconded by Reed—motion approved by all.

Treasurer Report: No new reports. Matthews made a motion to place the treasurer's report on file, seconded by Vondrasek —motion approved by all.

County Reports. Commissioner Garber says the county is still working at completing the 2019 audit. She and others have been discussing accounting training for county employees. MERS is a 44-million-dollar debt, and the county is looking at bonding as one possibility to come up funds for retirement deficits.

LSW Emergency Services Report. None

Board reports: Supervisor Matthews says MAGNET sent a thank you letter for Sciota Township's 2020-21 contribution. We are still waiting for our 40-hour brush and trimming services from the Road Commission. The Road Commission check is still being held until an additional check from the state is received. Clerk Parker-Wing says she has received many phone calls about AV ballots. We have submitted 3 election reimbursements to the State of Michigan for 2020 totaling just over \$2,000. The clerk submitted a question to the State of Michigan enquiring whether AV ballet overtime hours can be claimed as overtime reimbursement with the state-she's waiting for their reply. We need to reschedule the November 3, 2020 public accuracy test of the Auto-Mark voting machine due to non-receipt of the chart/mark deck prior to October 12. Trustee Vondrasek gave an overview of land division and lot line changes from the October 5, 2020 planning commission meeting. Trustee Reed had none.
