

Sciota Township Board Meeting –November 9, 2020

The November 9, 2020 meeting of the Sciota Township Board was called to order by Supervisor Matthews at 7:00 pm at the Sciota Township Hall. The Pledge of Allegiance was given by all. Members present were Supervisor Matthews, Clerk Parker-Wing, Trustee Vondrasek. Absent: Treasurer Doyle and Trustee Reed. Guests present were Diane Baclawski, Mike and Diane Dowler, Charlene Austin, Dennis Hill, Rashawn Schleicher, Kim Palmer, Jay and Belinda Southwell and Cindy Garber.

The minutes of October 12 meeting were approved as written, on a motion by Matthews, and seconded by Vondrasek. Trustee Vondrasek moved to accept the treasurer's report and place it on file, seconded by Parker-Wing – motion passed, approved by all.

Public Comment: none

County Commissioner Report: Cindy Garber has been re-elected through 2022. She says the 911 board meeting fund balance is \$229 million after a 50% down payment on dispatch radios for the fire department. There has been discussion of placing a new fence around the 911 building, which Cindy is not in favor. Additionally, there has been discussion concerning the placement of cameras throughout the Surbeck building.

LSW and Emergency Services Report: October emergency report totals were delivered by Dennis Hill. James Betts is the new LSW fire chief.

Board reports: Supervisor Matthews received MTA information for new board members and discussed possible training with Kim Palmer. **Clerk Parker-Wing** noted that on election day, internet at the hall would not connect for an hour or so and ended up conversing with technical support. She received positive feedback from several people that the November 3 election hall setup had a good flow-through. There are approximately 1,500 Township voters. We received approximately 620 absentee voting ballots and over 500 walk-ins. **Trustee Vondrasek** thought the hall voting seemed as though it was going smoothly when he was there.

Old business: In regard to internet service at the township hall during the month of an election, Clerk Parker-Wing intends to turn in only the wireless hotspot data charges from her bill.

New Business:

Kim Palmer is the new treasurer. She started the position on November 20, 2020 and plans to attend training in January and/or February 2021.

There were no public comments.

Vondrasek moved to pay bills and Matthews seconded the motion-- it passed.
