

Sciota Township Board Meeting –December 14, 2020

The December 14, 2020, meeting of the Sciota Township Board was called to order by Supervisor Matthews at 6.59 pm at the Sciota Township Hall. The Pledge of Allegiance was given by all. Members present were Supervisor Matthews, Clerk Parker-Wing, Treasurer Palmer, Trustee Vondrasek and Trustee Reed. TREASURER REPORT: Parker-Wing moved to accept the treasurer’s report and place it on file, seconded by Matthews.
