## Sciota Township Board Meeting –January 9, 2023

The January 9, 2023, meeting of the Sciota Township Board was called to order by Supervisor Matthews at 7:01 pm at the Sciota Township Hall. The Pledge of Allegiance was given by all. The members present were Supervisor Matthews, Clerk Parker-Wing, Treasurer Palmer, Trustee Reed and Trustee Vondrasek. ### **MINUTES:**

On a motion by Parker-Wing, and seconded by Reed, the minutes of the December 12, 2022, meeting were approved with corrections. (Kim Palmer's board report of "\$1,900 cost for BS&A program fees" should be \$1,600).

**TREASURER'S REPORT:** Trustee Reed moved to accept the treasurer's report and place it on file, seconded by Palmer. The checking account balances were: General Fund \$33,736.44; Tax Fund \$349,511.66; Money Market \$33,982.29; and ARPA Funds \$69,915.33.

LSW AND EMERGENCY SERVICES REPORT Dennis Hill gave an update on E911 calls for December.

**BOARD REPORTS: Supervisor Matthews** attended the Looking Glass River meeting; it has taken approximately 1.5M to clean out approximately 36 miles of river over a number of years. Matthews distributed the County's 'road wish list' of projects for 2023. **Clerk Parker-Wing** has been working on budget income/expense budget reporting for the January 2023 budget workshop. **Treasurer Palmer** discussed an accounting issue with BS&A financial software which resulted in funds being sent to the County later than usual. **Trustee Reed and Vondrasek** had no new reports.
